**EFFECTIVE JULY 1, 2020 KEYSTONE COLLECTIONS GROUP IS YOUR  
NEW CURRENT REAL ESTATE AND PER CAPITA TAX COLLECTOR**

Keystone Collections Group will serve as the new Real Estate Tax and Per Capita Tax collector for residents of the Northampton Area School District. You will receive your Real Estate and Per Capita Tax bills separately on or about July 1, 2020. You will now have three options to pay your Real Estate Tax and Per Capita Tax.

**Online**

With Keystone's *e-Pay* you can pay your tax in minutes, on time and with confidence. There is no additional cost to pay through an online transfer from your bank account. You may also pay by using Apple Pay, Google Pay, or by credit card. A 2.5% bank processing fee applies to these credit payment options. Print an online receipt right from your bill.

**Mail**

Visit [www.KeystoneCollects.com/Pay](http://www.KeystoneCollects.com/Pay) to obtain a receipt online. You will use the invoice number from your bill. For a receipt by mail, include a self-addressed, stamped envelope.

**In Person**

You can pay your bill in person at Keystone's Tax Office, located at 3606 Route 378, Suite A, Bethlehem (within the Black River Plaza) beginning Monday, July 6, 2020. Due to PA Department of Health and CDC directives, only one person will be permitted entry into the office at a time to maintain required social distancing. Visitors will be required to bring and wear a mask. Tax payments will be accepted, but no other business will be conducted in person in the office, as a courtesy to others who visit the office to make tax payment. Please have your bill handy for payment; paid bills will be stamped PAID as your receipt. Hours are Mon-Thurs 8 AM - 4 PM, closed 12-12:30 PM for lunch. (Hours subject to change due to COVID-19. Please call 1-866-539-1100 or check website for current hours.)

*Tax bills will continue to be mailed directly to taxpayers. If a mortgage company or bank pays your real estate tax bill from an escrow account, you must forward your tax bill to them so your mortgage company or bank can pay your bill on time.
